This project consists of the renovation (12,719sf) and addition (base bid 1,451sf, alternate 1,476sf) to the existing National Guard Readiness Center in North Wilkesboro, NC original drawings dated November 1952, renovation (4,422sf) and addition (428sf) to the Unit Training Bay (UTB) and construction (1,936sf) of the Unheated Storage Building (USB). The scope consists of building renovations, additions, new construction including new plumbing, mechanical, electrical, fire alarm, communications, and finishes throughout. The existing buildings are masonry load-bearing construction with steel and concrete framing/structure and deck. All hazardous materials such as asbestos and lead shall be removed as part of the scope.
