The existing walls shall be epoxy painted, existing deck and structure shall be painted, existing pit infilled with concrete, and the existing concrete slab shall have a resinous flooring system installed. Project also includes minimal mechanical and electrical work associated with the lead cleaning and remediation. No alterations are being made to life safety, occupant load, or path of egress. This project includes all other work as shown, indicated or reasonably implied on the drawings and/or specifications for a complete, first class job.*
