SCOPE OF WORK

This project consists of the cleaning, demolition, and remediation of the existing indoor firing range into general storage space. This project includes lead cleaning, removal of all associated backstops, deflectors, and other associated firing range items. The existing walls shall be epoxy painted, existing deck and structure shall be painted, existing pit infilled with concrete, and the existing concrete slab shall have a resinous flooring system installed. Project also includes minimal mechanical and electrical work associated with the lead cleaning and remediation. No alterations are being made to life safety, occupant load, or path of egress. This project includes all other work as shown, indicated or reasonably implied on the drawings and/or specifications for a complete, first class job.

PRE-BID CONFERENCE

*A Pre-Bid Conference will be held for all invited bidders and vendors on **July 22, 2021 @ 11:30 am at the Forest City Readiness Center, 890 Withrow Rd., Forest City, North Carolina.** The Pre-Bid Conference will address project specific questions, issues, bidding procedures, bid forms and a walk-thru of the existing site and building. The Pre-Bid Conference will also identify preferred brand alternates and their performance standards that the owner will consider for approval on this project.*

In accordance with General Statute GS 133-3, Specifications may list one or more preferred brands as an alternate to the base bid in limited circumstances. Specifications containing a preferred brand alternate under this section must identify the performance standards that support the preference. Performance standards for the preference must be approved in advance by the owner in an open meeting. Any alternate approved by the owner shall be approved only where (i) the preferred alternate will provide cost savings, maintain or improve the functioning of any process or system affected by the preferred item or items, or both, and (ii) a justification identifying these criteria is made available in writing to the public.
